The National Counter Terrorism Policing Network is the national collaboration of police forces across the United Kingdom responsible for counter terrorism operations and strategy. The British

government has designated 58 organisations as terrorist and banned them. 44 of these organisations were banned under the Terrorism Act of 2000.
