I-864P, 2019 HHS Poverty Guidelines for Affidavit of Support Means-Tested Public Benefits Federal Means-Tested Public Benefits: To date, federal agencies administering benefit programs have determined that federal means-tested public benefits include food stamps, Medicaid, Supplemental Security Income (SSI), Temporary Assistance for Needy Families (TANF), and the State Child Health Insurance Program (SCHIP).

These guidelines are based on the current poverty guidelines published by U.S. Department of Health and Human Services (HHS). To support an intending immigrant and his/her family members, the sponsor(s) must generally show that their income level is above 125% of the U.S. poverty line for the family unit.

The poverty guidelines also are used as an eligibility criterion by a number of other Federal programs. The poverty guidelines issued here are a simplified version of the poverty thresholds that the Census Bureau uses to prepare its estimates of the number of individuals and families in poverty.

USCIS Issues 2019 Poverty Guidelines: Raises Required Income Level for Family Sponsors of Immigrants To overcome a possible finding that the immigrant is inadmissible as a likely public charge, the U.S. sponsor will need to show income and/or assets that exceed the annual Poverty Guidelines levels, which went up in 2019.
